



HARVEST TODAY LIMITED WARRANTY

Harvest Today, LLC (“Harvest Today”) warrants that all products sold by Harvest Today (“Products”) to an applicable buyer (the “Buyer”) will be free from defects in material and workmanship for the following time periods from the date of shipment:

Harvest Today will repair or replace any products or parts of a product that prove to be defective during the Warranty period. This excludes defects caused by normal wear and tear, abusive or abnormal use of product, damage caused by the carrier in transit, and product modifications and/or attachments not approved by Harvest Today.

Harvest Today may repair or replace, at its sole discretion, any portion of the subject product which proves to be defective under the terms of this limited warranty at no further cost to the buying party. Harvest Today shall be liable under this limited warranty only for the cost of repair or replacement of defective product or part. Buyer is responsible for any labor and shipping costs associated with repairs or replacement. Harvest Today will not be responsible for any damage to customer’s property caused by incompatibility of the product with customer’s flooring and other customer property.
